The fees charged to Provisional Regulated Members of the College of Alberta Denturists will fund costs normally incurred by the College.

ALL APPLICANTS:

- Payment of the invoiced fees is due in full on or before the date specified by the College.
- Upon payment of the fees and any arrears or penalties, (and electronic transmission of a complete and correct applicable application form) the Registrar must issue to the Provisional Regulated Member, a written confirmation that the Provisional Regulated Member is registered in the Province of Alberta, subject to his/her compliance with the *Act*, the Regulations, and the Bylaws.

RENEWAL APPLICANTS:

- Pursuant to the College of Alberta Denturists Bylaws, notification of fees will be posted on the College website at least thirty (30) days before the fees are due. The notification will state the amount of the fees, the date at which payment is required, and the consequences of failure to pay on or after that date. .
- Each Provisional Regulated Member must pay to the College of Alberta Denturists, an annual Registration Fee, by the date required by the College.
- Pursuant to the Denturists Profession Regulation, Provisional Regulated Members who have previously been registered for one year may make application for the Extension of a Provisional Regulated Member Registration, by completing the appropriate College issued form(s) and remitting the invoiced fees.
- Where a Provisional Regulated Member pays the invoiced fees after the date required by the College by the date required, the Provisional Regulated Member must also pay a late payment fee.
- Where a Provisional Regulated Member fails to pay the invoiced fees that Provisional Regulated Member ceases to be registered and cannot practice as a Provisional Regulated Denturist.

REINSTATEMENT APPLICANTS:

- If an individual, who is a former Provisional Regulated Member, wishes to make application for reinstatement of the Provisional Regulated Member registration and Provisional Regulated Permit, the individual must pay the Provisional Regulated Member Permit fees as well as a Reinstatement Application Fee. The Reinstatement Application Fee is non-refundable once the application has been processed.
